<u>150 years ago</u> (Jan-Mar 1863)

Jackson Express, Jackson, Ohio Thursday, March 19, 1863

Died at the residence of her husband, in Jackson at 1 o'clock on Monday morning, the 10th of March 1863, Mrs. Julia Ann Dungan, wife of Levi Dungan and the daughter of Jacob and Perinelia Westfall, 37 years, 1 month and 7 days. Her disease was an affection of the lungs (commonly denominated Consumption).

She enjoyed the reputation amongst her acquaintances of being a person of good sense and greatly devoted to her family and friends. She left her husband with the care and responsible charge of six children—one very young and all delicate in health. Such is the way of this world of trouble and death.

Died

At Jackson, on the 6th inst., of Consumption, Charles S. Nelson, aged 24 years, 11 months and 11 days. Mr. Nelson worked at the Printing business until his health failed, some three or four years ago. He was a young man of quiet and inoffensive disposition, and was respected by all who were acquainted with him.

Mrs. _____McKetrick, wife of John McKetrick, was buried on the 8th inst. We learn that she died of a disease resembling Consumption. She was probably from 30 to 35 years of age; leaves six small children to increase the cares of her husband, and to attract the sympathy of all acquaintances. During her entire life, she enjoyed the good opinion of her friends, neighbors and acquaintances.

She was of uniform disposition – giving her chief care of late years to her family and her own affairs and was peculiar and happy in avoiding all interference with the affairs of her neighbors. In this regard her example would be a profitable lesson to many women who are yet living.

In conversation with a friend a few days since, a number of anecdotes were related of Francis Smith, "Old Frank" as he was familiarly called, the man after whom the G.A.R. at this place is named. One anecdote was given which illustrated the imperturbable spirit of the man, and the futility of an attempt to arouse him to anger. Smith and a number of others, including the late William McGhee, came to Jackson and were having their own fun, when two or three large men from another part of the county became very angry and wanted a row. Smith, in his sharp, cutting way, talked to them until they threw their coats and began prancing about like caged lions. When their rage had reached its highest pitch, Smith coolly walked up to the biggest one, squinting his eye at the man's vest, remarked: "Why, my friend, there's a bed-bug on your vest." The bully began to fume and swear with fearful vigor, when Smith, without the least show of excitement, reached out and brushed his hand across the

fellow's vest, remarking: "Oh, don't get excited about it, I'll just brush it off!" The secret of the matter was, very few men could afford to tackle Smith, and the bully knew it.

Emmett Barlow Lost His Life In a Mine Accident About two tons of slate fell upon him crushing him to death instantly.

This is the season of the year when mine accidents occur regularly and a fatal accident occurred Jan. 8, at the Goralope and Barbour mine in Coal Township.

Emmett Barlow who was drawing pillars was the unfortunate man. At about 8 a.m. a mass of slate fell crushing him to death.

The remains were brought to this city after being viewed by Coroner W. A. Ray, and prepared for burial by Undertaker Al Wood. The funeral was held Saturday. Interment at Exline's grave yard.

Barlow was 32 years old. He leaves a wife and three young children to mourn their great loss. Many friends sympathize with them in their great bereavement.

Ned Hughes Guided Morgan's Raiders

The last issue of the Waverly Watchman contains an article about Ned Hughes, an Adams county man who guided Morgan's Raider through Pike County to Jackson where he left them.

Hughes was tried for treason, but escaped punishment, according to the Watchman's story,

by fleeing to Canada, where he remained until after the war.

This raid occurred in 1863. Morgan's Raiders destroyed the office of this paper because its editor was such a Progressive for his time. The paper did not stop however, and it is still advocating the principles of Abraham Lincoln.

Prevented by Quick Action of Department, Blaze at Johnson's Blacksmith Shop. Caused \$500 Damage

The fire alarm sounded Wednesday at 1:30 p.m. and the department made a quick run to George Johnson's blacksmith shop, where fire had broken out. It was only a matter of a few minutes until the flames were under control, but the alarm had not been sent in until the whole inside of the stable at the rear was a flame. The stable was practically destroyed and the roof of the shop was damaged. The loss is estimated at \$500.

Mr. George Johnson, the blacksmith, had only been away from the shop a few minutes and stated that there was only a small fire on the forge when he left. He could not account for the fire, which seems to have started in some hay in the corner of the barn. The building belonged to P. R. Johnson.

The quick work of the fire department prevented a big fire for a brisk wind was blowing and it would not have taken long for the flames to spread among the numerous frame buildings which were near.

At the time the alarm came in the fire department was making a change of the hose and it was only a matter of a minute or two until the company was throwing water.

William Jackson Jenkins was born on December 10, 1831 to Amos and Hester Yeauger Jenkins. He married Sarah Ann Faught February 2, 1850 in Jackson County, Ohio. William and Sarah are the parents of George W., Rose Anna, Carrie A., Effie Jane, William Wellington, Edgar Darwood, Hulda Lenora, Amos Frank, Ernest F. and Nellie Mae. He enlisted in the Civil War as a Pvt. in Co G, 27th O.V.I on August 14, 1861 and was discharged August 18, 1864. William and Sarah are buried at the Mathers-Pierce Cemetery, Jackson County, Ohio

In Memory of Samuel Nally

Samuel Nally, an old soldier who has been a long sufferer from that dreadful disease cancer, died last Sunday at the home of Mrs. Demma Calhoon of near Obal, where he had made his home for a number of years.

The deceased was a veteran in the Civil war, having served as a Private in Co E 179 O.V.I and was drawing pension of \$22 per month at the time of his death.

He was never married and was 71 years of age at the time of his death. His early manhood was spent in Jackson county, but for a number of years has made his home with Mrs. Calhoon, a distant relative, who has always looked well after his comfort, being especially attentive and kind during his last terrible suffering.

The remains accompanied by Undertaker Butler, Mrs. Calhoon and daughter Hazel, was taken to Jackson Tuesday where the interment took place at Pleasant Grove cemetery, a few miles out of Jackson near his former home.

In addition to the above it may be noted that Nally was also a member of Co F 129 O.V.I. He lived for years with friends in Lick Township.

Mr. Richards was one of the patriotic boys of the Sixities and when that great national crisis of the civil war came upon us and it became necessary that the strength of our best manhood should be sacrificed in camp, prison and on the battlefield, he was one to volunteer his service and if need be to sacrifice his life that the cause of the union might prevail. He was mustered in with company H, 117th O.V.I., November 13, 1862, at Camp Ashland, Ky., at the age of 19 and mustered out at Knoxville, Tennessee, July 26, 1865, thus giving to his country three years of his best manhood. His comrades say that his loyalty, valor and bravery were an honor to American soldiery.

John J. Markham Dies at Eighty-Four

Word had been received by Mrs. Martha E. Twaddle, of Columbus of the death of her brother, John J. Markham, aged 84 years, who dropped dead in the post office at Partridge, Kan., his home town on February 3, 1920. He was born November 27, 1836, on a farm in Smoky Hollow, Jackson County, and was the oldest son of Richard and Eleanor Markham. He was a civil war veteran, having served from 1861 to 1865 with Co. E, 56th O.V.O. which was recruited at Centerville, Gallia County and was in the first battles of Shiloh and Pittsburg Landing. He left Jackson county shortly after the close of the war and settled on a farm in Kansas where he has since resided. This is the second

death in the Markham family within two months, the death of Jefferson being recorded in Standard-Journal of January 21st. He is survived by a wife and one son, James. Three brothers and two sisters also survive, being Thomas living at Waverly, Timothy, at Piketon and William at McArthur, Ohio and Mrs. Martha E. Twaddle of Columbus and Mary Jenkins of Savannah, MO. He was a subscriber to the Standard-Journal for many years and wrote many interesting articles on his early recollections of events in Jackson county.
