Meeting Minutes – April 12, 2014

Meeting Minutes:

1. Beverly Griffiths announced that The James Cemetery Fund received \$3000 from the Tourism Board. Along with other funds, there should be enough to pay for the rest of the fence & gate materials. James Cemetery Project Chairman, Anthony Coyan is looking for someone to build the column needed at the end of the fence. And Anthony Coyan will be installing the last section of the fence & gate this spring.
2. Ruth Hayth, Program Chairman, announced that Berta Lockhart of Friends of Athens Asylum Cemeteries, Inc. will be the speaker at the May meeting.

Old Business:

1. Donna Scurlock announced that the Microfilm for the Wellston Telegram Newspaper is in the Jackson City Library now ready to use.
2. There was a discussion about prices to charge for requests of information looked up which Bob Lewis is doing. Charles Weese made a motion to charge \$2 for up to 4 pages including postage. Megan Malone seconded the motion. Motion passed.

New Business:

1. The 4th annual: "Rendezvous at the Rock" Native American Celebration will be held at Leo Petroglyphs and Nature Preserve on Saturday, April 26, from 10 am -4 pm. There's something for the whole family to enjoy. Entertainment, regional food, and lots of exhibits and demonstrations. JCOGS was invited to participate.

3. Cynthia Dalton brought copies of an article about Jackson County, Ohio Civil War Veterans graves that was in the Jackson Telegram Newspaper on March 19, 2014. Anthony Coyan is requesting help to give more proper recognition at Civil War Veterans gravesites in Fairmount Cemetery by making sure about 400 Civil War Vets graves have at least a military flag holder & flag that can be replaced once a year. 4. Cynthia Dalton mentioned that she emailed Anthony Coyan about planting flowers in May for the James Cemetery Project.
